

**Description**

The GRX-IRI Infrared Interface allows auxiliary systems equipped with an IR emitter to control a GRAFIK Eye system. Up to 8 GRAFIK Eye Control Units can be Assigned to listen to the GRX-IRI.

**Features**

The GRX-IRI allows auxiliary systems to access basic functions using standard Lutron IR codes. These functions include:

- Selection of 16 Scenes plus Off on the Assigned group of GRAFIK Eye Control Units.
- Temporary Master Raise or Lower of all zones on the Assigned group of GRAFIK Eye Control Units.

The Assigned group of GRAFIK Eye Control Units is set using address (DIP) switches 1 to 8 on the GRX-IRI.

For ultimate flexibility, the advanced set of Lutron PRO IR codes can be used. These allow individual control of any GRAFIK Eye Control Unit or Zone within the system:

- Selection of 16 Scenes plus Off on any GRAFIK Eye Control Unit in the system (Example: Select Scene 1 on GRAFIK Eye Control Unit 2).
- Temporary Master Raise or Lower of all zones on any GRAFIK Eye Control Unit in the system.
- Raise or Lower any zone on any GRAFIK Eye Control Unit in the system.
- Save the current settings as a scene on a GRAFIK Eye Control Unit (only available with GRAFIK Eye 3500 or 4500 Series Control Units).

**Important Notes**

1. Install in accordance with all applicable regulations.
2. Do not connect high voltage power to device. Improper wiring can result in personal injury or damage to the device or to other equipment.
3. GRAFIK Eye Accessory Controls must be connected to the GRAFIK Eye Control Unit using Class 2 wiring methods, per the National Electrical Code®. Check with your local electrical inspector for the local code requirements and wiring practices in your area.

## Installation



### Warning:

Always turn Off the circuit breaker/MCB or remove the main fuse from the power line before doing any work. Failure to do so can result in serious personal injury or damage to the product.

Proper wiring of the GRX-IRI is dependent upon the GRAFIK Eye Control System that is providing power. GRAFIK Eye 3000 Series and GRAFIK Eye 4000 Series Control Units have different power limitations and wiring techniques. Please confirm the type of Control Unit to which the Interface is being wired and use the corresponding instructions that follow.

1. Turn power Off.
2. Mount in a standard U.S. 1-gang wallbox, 2.75 in. (70 mm) deep (available from Lutron - P/N 241-519), or directly to wall.
3. Strip insulation from wires so that 3/8 in. (10 mm) of bare wire is exposed for #18 AWG (1.0 mm<sup>2</sup>) wire.
4. Address the GRX-IRI. Each component in a system must be assigned a unique address. The GRX-IRI may be assigned to address 15 or 16 only. Set address (DIP) switch 9 to select address. Default address is 15.



**Note:** All GRAFIK Eye Control Units must be addressed for the GRX-IRI to operate. For instructions on addressing GRAFIK Eye Control Units, please consult the GRAFIK Eye Installer's Guide.

5. Set DIP switches 1 to 8 to Assign the GRAFIK Eye Control Units that the GRX-IRI will talk to. By default, all GRAFIK Eye Control Units will be Assigned.

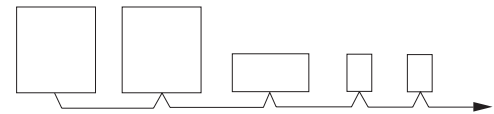
6. Wiring must be done in a daisy-chain and 1-to-1 configuration (please see Installer's Guide included with GRAFIK Eye Control Unit for more information). Each GRX-IRI terminal will accept up to two #18 AWG (1.0 mm<sup>2</sup>) wires.

**3000 Series System Wiring:**

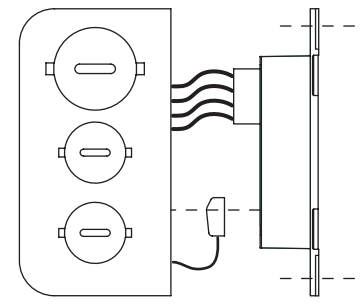
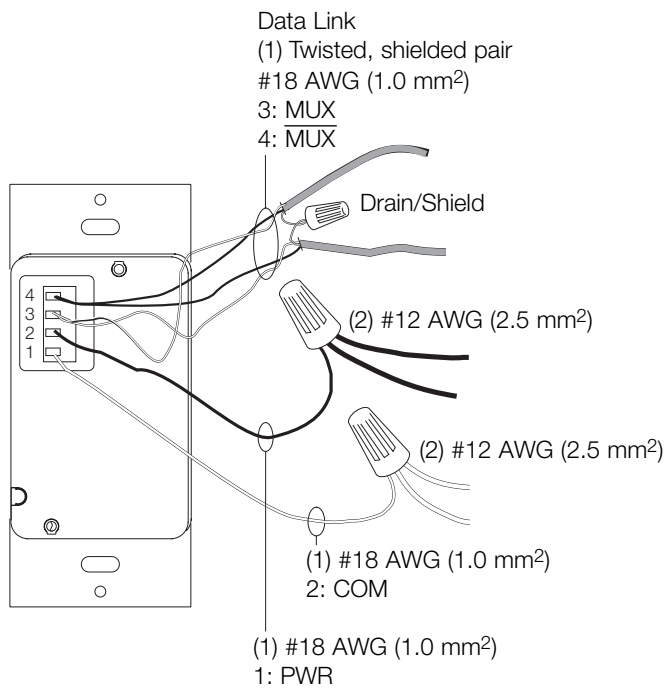
Connect four #18 AWG (1.0 mm<sup>2</sup>) twisted pair wires to the terminal block on the Interface.

**4000 Series System Wiring:**

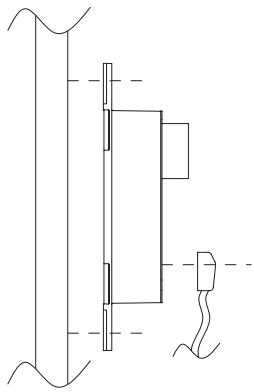
Connect two #18 AWG (1.0 mm<sup>2</sup>) shielded, twisted pair wires to terminals 3 and 4 of the terminal block on the Interface. Shielding must be connected as shown - do not connect to Earth/Ground or Interface. Two #12 AWG (2.5 mm<sup>2</sup>) wires are required for 1: PWR and 2: COM. #12 AWG (2.5 mm<sup>2</sup>) wire will not fit in terminals - connect as shown.



Daisy-chain Configuration

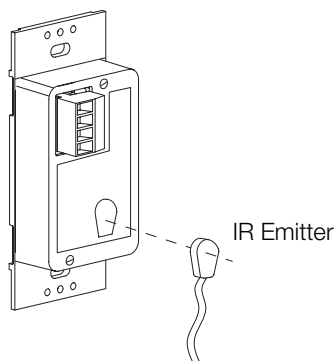


GRX-IRI Mounted in Wallbox
