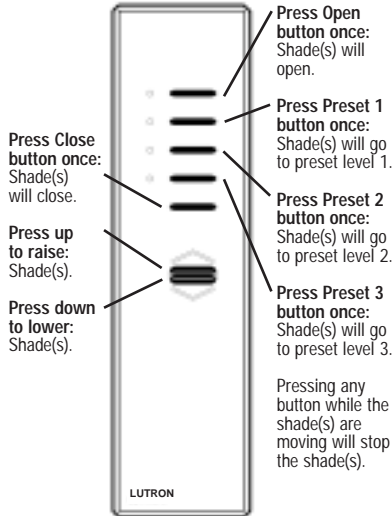

Description

The SVQ-3PIT Infrared Hand-held Remote Control provides remote shade operation from the palm of your hand. The Infrared Hand-held Remote Control transmits signals to Sivoia® or Sivoia QED™ Electronic Drive Units (EDUs). The Infrared Hand-held Remote Control is compatible with learnable remote controls. To access advanced features, please refer to the Sivoia QED Wiring and Programming Guide or the Sivoia QED Technical Reference Guide.

Operation

Point the Infrared Hand-held Remote Control at the Sivoia or Sivoia QED IR receiver, then use the buttons as shown below.



Easy Preset Programming

1. Adjust shade(s) to desired position.
2. Point the SVQ-3PIT at any of the Sivoia or Sivoia QED IR receivers.
3. Press and hold the desired Preset button for 5 seconds.



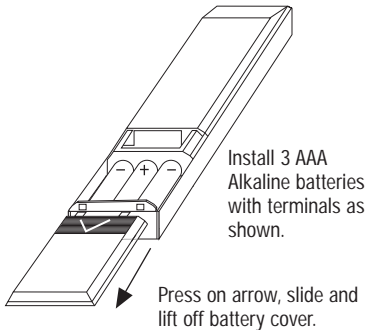
Note: Pressing any button while the shade is moving will stop the shade.

Battery Replacement

The SVQ-3PIT Infrared Hand-held Remote Control uses 3 AAA batteries which are pre-installed (see diagram). For best results use alkaline batteries. Do not use NiCad batteries.

To replace batteries:

1. Remove the battery cover.
2. Replace with 3 size AAA alkaline batteries as shown.
3. Replace the battery cover.



The Infrared Hand-held Remote Control is safe for use around baths and spas.

Troubleshooting

Problem	Causes	Remedies
Infrared Hand-held Remote Control has no effect on the Electronic Drive Unit (EDU).	Electronic Drive Unit (EDU) power is OFF.	Restore power.
	Dead, low, or no batteries in the Infrared Hand-held Remote Control.	Install new batteries.
	Infrared Hand-held Remote Control is too far away from the IR receiver.	Try moving closer to the shade(s) you wish to control. If an IR receiver is installed on the Electronic Drive Unit (EDU), verify that it is properly installed and the IR receiver is not obstructed (e.g. by curtains, fascia, drapes).
Presets are not being saved.	Batteries inserted incorrectly.	Install batteries per diagram.
	The desired preset button was held for less than 5 seconds.	Press and hold the desired preset button for at least 5 seconds.
Presets are locked.	Pressing any button while the shade(s) are moving will stop the shade(s).	Unlock presets. Refer to the setup guide that accompanied the EDU.
	Presets are locked.	Unlock presets. Refer to the setup guide that accompanied the EDU.
