Ballasts: REZ-132(-SC), REZ-2S32(-SC), REZ-3S32(-SC), REZ-2Q26(-M2), REZ-1T42(-M2), REZ-2T42(-M3), REZ-1T32, REZ-154, REZ-2S54

Requires: *GRAFIK Eye* 3000 Series Control Unit (6.6 A per zone; total of all zones combined not to exceed maximum capacity of control unit) OR
NFTU-5A/NTFTU-5A OR
SPSFTU-5A OR
DVSCFTU-5A3P/DVFTU-5A3P OR
SFTU-5A3P
Use the HP 2-4-6™ dimmer for loads that exceed 5A (wallbox dimmers) or 6.6 A (*GRAFIK Eye*) along with the control unit.

Wiring: Refer to the load wiring section of the *HP 2-4-6* installation instructions. The ballast is wired the same as an incandescent load.

Operation: If using the *GRAFIK Eye* 3000 Series Control set the corresponding zone to the **HP 2-4-6** load type. Refer to the *GRAFIK Eye* 3000 Series Installer's Guide for instructions on setting the load type of a zone.

If adjustments are made to the low-end or high-end trim, they must meet the following dimmed hot/live to neutral voltages at the ballast inputs.

Low End: 56 Vrms +/- 8V

High End: >115 Vrms

Note: A true RMS voltage meter **must** be used when taking these measurements.
